Panorama

Capping off the Panorama project is the **discovered candidate history** feature. When creating a waiver or exemption request, it is helpful to know the candidate's history in order to ensure the waiver or exemption is compliant. With the recent addition of an email field for candidates, users will now be able to **view a list of all recruitments, waivers, and exemptions associated to the candidate**. Users can also manually add historical data through the added history feature.

Recruit automatically looks for places in which the candidate's employee ID or any known email addresses have appeared.

Bugs 'n stuff

- Log reference information when reporting exceptions to developers
- Fixed an issue where a waiver with no candidate name was causing an error
- Fixed an issue where an artifact appears on screen when attempting to print a page
- Fixed a navigation issue with the workspace ribbon and the basic qualifications filter
