**Overview**

Effective 2025-26AY review cycle, the Teaching Information section in eFilePlus will include new labels and additional document types to support the [APM 210 policy revisions](#) (effective March 25, 2024) that address (1) consideration of mentoring and evaluation and (2) evidence of teaching and mentoring effectiveness. Additionally, these changes support the recommendations from the Joint Senate-Administrative Teaching Evaluation Implementation Committee (TEIC).

Below is a description of the previous state and new state effective 2025-26AY and a table that shows a summary of the differences between the previous state and new state.
