- You are **unsure of where to go**

# Ombuds – VPAR/VPAP Role Comparison

	Ombuds Office	Vice Provost for Administrative Resolution (VPAR)
<b>Constituents?</b>	Entire UCR community - students, staff, faculty	Predominantly faculty
<b>Scope of Issues</b>	UCR-related concerns	Predominantly faculty discipline
<b>Role?</b>	Designated neutral	Designee of Chancellor and Provost/EVC
<b>Reporting Office?</b>	Non-reporting (Confidential)	Reporting
<b>Can assist in informal resolution?</b>	Yes	Yes
<b>Acts on behalf of administration in formal faculty disciplinary processes?</b>	No	Yes
<b>Available to discuss issues proactively?</b>	Yes	Yes
